3.0 OFFICIAL OPENING KILLYHEVLIN BUSINESS CENTRE

The Official Opening of Killyhevlin Business Centre took place on Thursday, 13 November 2014. The tape cutting was undertaken by the Chairman of Fermanagh District Council, Bert Johnston, in the absence of Minister Arlene Foster who was unable to attend due to a family bereavement.

The ceremony was attended by 60 guests as well as the press and feedback has been positive and supportive. Press items appeared in the Irish News, Fermanagh Herald, The Impartial Reporter and the event was widely covered on social media.

4.0 REGIONAL START

In the year covered by this Annual Report, 198 clients were assisted to prepare Business Plans meeting the Annual Target set by Invest NI.

5.0 STEPS TO WORK

During the year, this Programme was replaced by Steps to Success in October 2014. The Steps to Success Contract has been awarded to the Reed Group – an international firm. Steps to Success does not have any Test Trading element to support a move to Self-Employment.

Fermanagh Enterprise Limited will have no role in the new Programme except in providing Business Plan assistance under the Regional Start Initiative.

18 individuals attended Basic Awareness and 24 completed their six months Test Trading.

6.0 TRADELINKS

Tradelinks was a Programme designed to provide Support and Mentoring to existing businesses who wish to trade across the Border. The nature of the Mentoring provided under Tradelinks is highly specialist and all mentoring was sourced externally.

During the year, 6 firms received assistance.

The Programme ended in May 2014.

7.0 EXPLORING ENTERPRISE PROGRAMME

During the year, 4 individuals completed the Programme preparing Plans for their Business and putting together a Portfolio for a Qualification in CCEA Accredited Training for a Level 2 in Understanding Business Enterprise.

8.0 RETAIL PROGRAMME

Training and Mentoring Scheme, Enniskillen was aimed at retail and hospitality businesses based in the town centre. 28 businesses were accepted onto the Programme. Businesses were assisted through:

- Mentoring tailored to address the issues unique to the retail and hospitality sector from specialist mentors. The areas covered included social media, search engine optimisation, customer service, employment legislation, shop layout and merchandising, financial management, card payment systems.
- Opportunity to avail of a mystery shopper visit.
- Opportunity to receive staff training.
- Training to sell on-line and through eBay 10 eBay shops set up. Amazon Training took place on Wednesday, 19 November 2014 for 6 businesses with follow-up one-to-one training for 3 others on Thursday, 27 November 2014.
- A full signposting service to other programmes.

A final Event was held on Friday, 28 November 2014 in the Townhall and participating businesses were presented with Programme Certificates.

9.0 YOUTH PROGRAMME

Funding has been received from the Royal Bank of Scotland to deliver a Youth Enterprise Programme to inspire young people from the Fermanagh and Omagh areas to take the next step in becoming entrepreneurs. The Programme will be delivered in partnership with Omagh Enterprise to reflect the new Council boundaries.

Twenty-four participants have been recruited and twelve workshops have been delivered covering a range of business topics such as digital marketing, on-line selling, market planning, presentation skills and tax/bookkeeping.

Participants are currently being assisted to develop business plans with a view to gaining an ILM Level 2 Award in Understanding Enterprise. A number of participants are also currently benefitting from free driving lessons which is part of the Programme.

A Celebration of Youth Event/Dragon's Den Competition will be held in June 2015 in which the participants will give presentations on their business ideas.

10.0 CHARITABLE STATUS

Our Application for Charitable Status has been successful.

The Charity Commission for Northern Ireland has accepted that Fermanagh Enterprise Limited is operated for the Public Benefit and has the appropriate Policies and Governance procedures in place. Indeed our Public Benefit Statement is now included in the Commissions Revamped Toolkit as an Exemplar to assist other applicants.

As documented in our Business Plan, the expertise and experience of the staff have been provided free of charge to a range of individuals, community groups, schools and stakeholder organisations. This has been recorded and can be broken down as shown in *table 4*.

12.0 ENTERPRISE AWARENESS

12.1 BUSINESS INFORMATION EVENT

On Tuesday, 27 January 2015, a Business Information Event was organised in conjunction with Fermanagh District Council/Survive and Thrive and Grow and Prosper Programmes.

A new format was implemented and the Event was called Fermanagh Bizcamp. The opportunity was taken to showcase the new Killyhevlin Business Centre where the event was hosted. This year, as well as inviting Business Support Organisations, local businesses were asked to take a Trade Stand to help them develop an increased awareness of their firms and give them access to potentially new business.

A series of Seminars devoted to social media, local on-line marketing and trading were delivered by Michael Hughes and Aine Bermingham and three successful start-up business promoters addressed the audience providing details of their Business experiences.

The format proved successful and a survey of participants on the night provided useful feedback. In summary, the Event was attended by 46 Businesses and Support Organisations and a total of 121 visitors. 95% of the visitors rated the Event either good or excellent. The remaining respondents rated the Event either average (2.5%) or poor (2.5%).

12.2 Company Profile

Maintaining adequate profile throughout the County and beyond to ensure maximum awareness among clients and others was a key strategic objective during the year.

Contributions to the local press may be summarised as follows:-
